

BUSINESS IS BOOMING IN THE JACKSONVILLE REGION: ICE ANNOUNCES NEW HEADQUARTERS IN DECEMBER 2024

Intercontinental Exchange (ICE), a financial and mortgage services company best known as the operator of the New York Stock Exchange, **announced in December 2024 that they will be establishing the national headquarters of its mortgage technology division in Jacksonville, Florida.**

With this expansion, ICE will bring 1,500 professionals to Northeast Florida to start, coming from cities like New York, Chicago, Boston and even London. **The companies expects to add more than 500 new jobs over the course of several years. The new jobs will range from front-office up to executive positions—paying an average wage of \$125,000 with benefits.**

"The new jobs will span a wide range, helping to ensure our city will continue to thrive for years to come," Mayor Donna Dean says, "Jacksonville is a tech city. That's why these companies are coming here. **We're a tech center.**"

ICE is investing \$173+ million in Jacksonville to assist in establishing this headquarters. In January 2025, the company purchased the 52.23-acre Merrill Lynch Deerwood Park North Campus from Bank of America for \$42 million, kickstarting the expansion.
